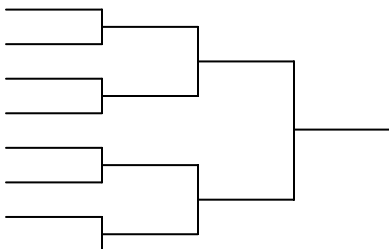

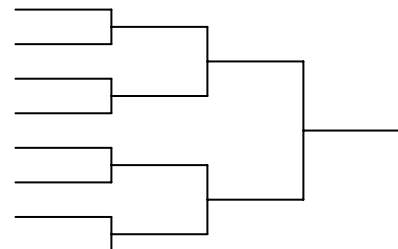

~ Rules ~

1. To participate in the Greater Peoria USBCBA tournament you must be certified through the Greater Peoria Bowling Association.
2. Bowlers must bring their USBC cards with them and show them to the tournament officials.
3. No more than two persons classified as "professional" bowlers may bowl on a five-person team and no more than one person classified as a "professional" bowler may bowl on a doubles team. A "professional" bowler is defined in the USBC constitution.
4. Bowlers must pay for both 2-person and single events the first time you bowl these events. You may bowl singles & doubles on separate squads.
5. Multiple participation is allowed in the Team Event, Doubles, and Singles but you may cash only once with the same partner. To cash in the Team event more than once, you must change two bowlers in your line-up. You may only cash once in the Singles event.
6. All Events is the first series you bowl in each event.
7. All prize fees returned 100% in cash awards, plaques, and jackets to each winner of handicap events. Winners of the actual Team, Singles, Doubles, and All Events will receive plaques & jackets only. Optional Scratch side pot pays cash prizes only.
8. At least one award will be given for each 8 entries in the Team, Singles, and Doubles. At least one award will be given for each 15 entries in the All Events. USBC Championship Chevrons will be awarded to the champions in each event.
9. Handicap and Actual Champions in each event will receive plaques paid for by the Bowling Center Hosting the tournament.
10. In case of ties for the 1st place in the handicap and actual events, both will be declared co-champion winners.
11. Error in scoring or calculation will be corrected by a Tournament Official immediately upon discovery. Errors must be reported within 48 hours after bowling.
12. Entry Fee will be \$20 per person per event. All Events is based on your 1st Team, Singles, & Doubles Events bowled.
13. Optional Scratch is \$5 per person per event and pays cash prizes only. \$25 per Team, \$10 per Doubles, \$5 for Singles.
14. Bowlers not yet 18 years of age, must have a consent form on file prior to bowling in the tournament.
15. Handicap will be 90% of 230. USBC tournament rule 319a (15-pin rule) & 319D DOES NOT APPLY. Maximum of 72 pins per game per person.
16. Averages indicated on the entry must be highest certified USBC average for the '09-'10 winter season (minimum 21 games). If no average for the '09-'10 winter season, a bowler may use their current average (minimum 21 prior to the first time bowling in the tournament). If no established average for '09-'10 or current '10-'11 average for 21 games or more, they must bowl scratch.
17. Any league that is certified as a "Sport League" or a certified league bowling on a Pro or sport condition shall be subject to average adjustment according to USBC rule #202 A-E(sport league averages).
18. It shall be the bowler's responsibility to verify their average, whether originally submitted by the bowler, their captain, or others. Failure to use the proper average or make a correction up to the completion of the first game of a series, may disqualify score if submitted average is lower than actual average or base prize winnings on submitted average if it is higher.
19. Only line-up changes permitted, if it is a substitute bowler the change should be made by the team caption prior to bowling.
20. In the event a game (or portion of a game) is lost, due to malfunction of an automatic scorer, the game shall be re-bowled at a time and date determined by a tournament official.
21. In the event of mechanical failure, the tournament official reserves the right to move bowlers to another pair of lanes.
22. The average of bowler may be adjusted according to USBC tournament rule 319c.
