Tournament rules

1. This tournament is open to all seniors holding a USBC Peoria Association membership card.
2. Seniors who are not members of the United States Bowling Congress may purchase membership card.
(Women - \$15.00 & Men \$17.00)
3. Handicap will be 100% of a 220 average.
4. Tournament will be divided into six classes: Class A – 70 years and older, Class B – 65 to 69 years of age, Class C – 60 to 64 years of age, Class D – 55 to 59 years of age, Class E – 50 to 54 years of age, and Class F Mixed Doubles.
5. Bowler's age will be determined as of the start of the tournament.
6. Double's partners do not have to be in the same class or age bracket. Doubles team will be classified according to the youngest partner's age. There are no age brackets to the Mixed Doubles event.
7. Entrants may compete more than once in the doubles event only, but cash only once in each Class (age bracket) with the same partner. All-event scores will be figured from the first doubles event bowled.

8. Each event must have a scheduled date and time. You cannot bowl both doubles and singles in the same squad time. Please check in at least ½ hour before squad time.
9. No touring 1 or touring 2 professional may compete in this tournament.
10. Prize fee will be returned 100%; prize ratio is at least one prize for six entries in a class.
Refund at Tournament Manager's discretion.
11. Trophies for All-event winners in each division. Handicap All-events winning entry will be refunded with proof of Participation in the 2010 state senior tournament- (excluding Class E- 50 to 54 & the Mixed Doubles).
12. If you are not contacted with any different information, you will bowl your first choice of dates and times.
13. USBC Rules 319d & 319e do not apply.
14. Entering averages:
 - a) Highest USBC – WBA/BA sanctioned average (based on 12 games) for 2009- 2010 season (319a-1)
 - b) Bowler with no 2009 –2010 average may use a 2010 summer league average based on 12 games or more (with proof of average).
 - c) Bowler with no average for last season or no summer league average may use the current season average from 12 games or more at the time of bowling.
 - d) Bowler with neither of the above average will enter at 180 average for men and 165 for women.
 - e) It is the bowler's responsibility to verify the accuracy of his or her average whether originally Submitted by the bowler, partner or other. Failure to use the proper average shall disqualify the score if the submitted average is lower than the actual average thereby resulting in more handicap. Prize winnings will be based on submitted average if it is higher than the actual average. Corrections in averages can be made up to the completion of the first game of a series Or within 48 hours after the completion of a series if the Tournament Manager, prior to the completion of the first game of the series, has given written consent to the bowler authorizing such extension of time to correct the average.
